Important: pursuant to § 55 para. 2 number 1 and § 82 of the Residence Act

I was cautioned that

- under § 55 para. 2 number 1 of the Residence Act I can be expelled from the country if during administrative procedures which are conducted by the authorities of one of the countries applying the Schengen Implementation Agreement, I give false or incomplete information in Germany or abroad, in order to obtain a German residence title, or to obtain a Schengen visa, or a substitute passport, or to obtain exemption from the obligation to carry a passport, or to obtain suspension of an expulsion order or if, despite a legal obligation on my part, I fail to cooperate in measures of the competent authority responsible for the implementation of this law or the Schengen Implementation Agreement.
- it is an offence, under § 95, para. 2, number 2 of the Residence Act to supply incorrect or incomplete information, punishable by the imposition of a fine or prison sentence of up to three years. A foreigner can be expelled if he violates legal regulations and administrative rules, which includes incomplete and false information regarding the statements above (§ 55 para. 2 number 2 of the Residence Act). A residence title once granted can be revoked.
- I am obliged to put forward without delay, my interests and any facts in my favour, unless they are apparent or already known, quoting verifiable circumstances, and I am obliged to submit without delay, any required proof regarding my personal circumstances, any other required documentation, permits or other certification. Any facts put forward and any proof supplied subsequent to expiration of the time limit set by the immigration authorities for submission of these documents, may be disregarded.
- as a rule, a fee will be charged for the processing of the application above. This fee will not be reimbursed if the application is withdrawn or rejected.

The authorities responsible for the implementation of the Residence Act are empowered, for the purpose of implementing this law and the provisions relating to foreigners as laid down in other laws, to collect personal data to the extent that this is required to fulfil their duties under the Residence Act and under provisions relating to foreigners in other laws. It is legally permissible to collect data as defined in § 3 para. 9 of the German Data Protection Act and in corresponding provisions of the data protection acts of the German Federal States, to the extent that this is necessary for the fulfilment of duties in individual cases (§ 86 Residence Act).

The information to be given in this application is required under the Residence Act. There are numerous provisions, and consequently the legal foundations that apply to individual cases are available from the immigration authorities on request.
